


New development and redevelopment will be prioritized on surface parking and in commercial areas to **minimize displacement**

### **Transportation Recommendation Highlights**


- Development will provide the streets, blocks, and connections as generally depicted on Street Network Map.

- When possible, the City will work with property owners to add additional bicycle connections not shown, to other parks and routes.





### **Transportation Recommendation Highlights**

- The intersection of Seminary Road and Beauregard Street will be improved to better accommodate and ensure the safety of all users.
- The City will explore options for improving safety and accessibility for all users on Seminary Road, generally from Mark Center Drive to Library Lane.
- As part of multimodal transit enhancement, a new bus facility will be established within Southern Towers.



- Focusing on All Modes of Transportation and <u>Sustainability</u>
  - Street and bike networks create a better-connected network for all users, including low-carbon users





## FY 2025 Alexandria Transit Strategic Plan (ATSP)

- Annual DASH Service Plan which identifies any service, policy or program changes for next year (FY25)
- Replaces previous Transit Development Plan (TDP) based on DRPT requirements.



## FY 2025 ATSP Service Changes

#### Line 104 Reduction

If approved, Line 104 weekday peak service would be reduced from every 30 minutes to every 60 minutes to offset additional city budget needs.

Final Decision on this reduction will be made by Alexandria City Council through the FY 2025 Budget Review & Approval Process in March/April.









## FY26-FY27 ATSP Service Changes

- Line 30 | improve midday, eve and weekend headways to 15 minutes.
- ▶ Line 32 | improve weekday peak headways from 30 to 15 minutes.
- Lines 103 & 104 | improve peak headways from 30 to 20 minutes.
- ► WMATA Better Bus Network Changes | TBD
- ► Line 102 | improve weekday midday headways from 60 to 30 minutes.
- ► King Street Trolley | extend route from King St. Metro to Eisenhower Metro and extend operating hours from 11:00 AM to 6:00 AM.
- ► West End Transitway | New BRT service to replace most of Line 35. West End Transitway service operator, service levels, and impact on adjacent DASH/WMATA routes to be finalized by late 2024.

### **Budget Overview**

- On February 27, the City Manager presented City Council with a proposed operating and capital budget for Fiscal Year (FY) 2025
- Adoption is scheduled for Wednesday, May 1.
- Proposed budget
  - General Fund Base Operating Budget FY24: \$911.3 million
  - 10-year CIP Budget FY24-33: \$2.33 billion

### **Transportation Operating Highlights**

- DASH Increases 16.6%
  - Labor cost increases
  - Reduction of service on line 104
  - Reductions in administrative costs
- WMATA
  - Increases \$700,000
  - May have to include additional ~\$10 million to close operating



### FY25-FY34 CIP Highlights

- \$12.9 million Complete Streets-Vision Zero
  - Excluding several specific projects
- \$8 million Safe Routes to School
- \$10.4 million Sidewalk Capital Maintenance and sidewalks for CS
- \$189.1 million WMATA Capital Program
- \$64.6 million Street reconstruction and resurfacing
  - Approximately 50-55 lane miles in FY 2025
- \$75 million Duke Street Transit Corridor
- \$30.3 million DASH Bus Fleet Replacement and Electrification
- \$21.8 million Smart Mobility
